

**So what, what now? I need your help.** – Heston Russell

On Wednesday this week, the appeals process for my judgement against the ABC closed. With this, the ABC has by default accepted that they and two of their journalists were guilty of irresponsibly defaming me and my soldiers, and in doing so have caused serious harm. Now sending you this today, there is still not a word, let alone acknowledgement or an apology from anyone at the ABC. The same journalists are still working and receiving their full income (paid for by you, me and every other Australian taxpayer). Zero responsibility, zero accountability. This from the same media who are the first to profess their self-appointed position as a ‘fourth-pillar’ in our democracy and seek to hold others accountable. This absolute hypocrisy goes against our core Australian values and sets a disgusting example for all young Australians to learn from, and for our country to be seen with internationally.

At the start of this month I sent a request to both the Prime Minister, Anthony Albanese and the Defence Minister, Richard Marles, to meet with them next week in Canberra during the Parliamentary sitting week. My request was to discuss this and the [Veterans' Protection Act](#) we propose to better protect our Veterans from this irresponsible trial by media back home in Australia after serving on operations for our Nation. Yesterday, Richard Marles' staff member replied and said I should meet with the Veterans' Affairs Minister instead. I am still yet to receive any response from the Prime Minister. It's fascinating to realise how quick Albo was to jump in next to me when I campaigned for the Royal Commission (below) and be unwilling to even respond now even after the Federal Court ruling, let alone the devastating impacts we have seen these ongoing media attacks cause our Veteran community and families.



I find myself standing in a position where I see so clearly how those in government, elected by us, for us - are not with us. How they are not willing to support those who fight for all freedoms, including free media, when it is a choice between only allowing members of the media to report on war crimes once they are proven in a court to the criminal standard (beyond reasonable doubt). As a 5th Generation Veteran who has been proved to be targeted and having serious harm caused by our government funded media, I am so dejected by this rejection.

I need your support - because only through strength in numbers and making enough noise to get their attention, can we collectively achieve what is needed for our current and future Veteran community.

I need your support to please flood these two elected officials with letters that will require their unavoidable action. Albo & Marles have the power to ensure that this devastation to our Veteran community ends. With your support we can make this happen.

### **Nuclear veterans (From the United Kingdom) take legal action over 'illegally withheld' medical records.**

Military veterans who took part in nuclear weapons tests in the 1950s and 60s are to take legal action against the UK Ministry of Defence in an attempt to gain access to medical records they claim have been illegally withheld.

The son of one of the men who took part in the tests said the MOD had to be held accountable because disclosing the information would have "lessened the trauma... and anguish" suffered by their families.

Some of the claimants said they had had cancer, blood disorders and lost children - and their descendants have spoken of being born with obvious disabilities.

Nuclear test veteran is the first to hold new medal fresh off the production line

£200,000 funding scheme for programmes recognising nuclear veterans opens for bids  
In a statement, the MOD said it "remains the case that no information is withheld from veterans", but said it could not comment on ongoing litigation or claims.

According to the MOD, more than 20,000 military personnel were present at the UK nuclear weapon tests between 1952 and 1967 in Australia and the South Pacific.

As part of the legal claim, veterans said blood and urine samples taken at the Cold War weapons trials had been reclassified as

"scientific data" and placed at the Atomic Weapons Establishment - an agency of the MOD - which means they cannot be accessed.

Reportedly sources at the MOD said the archives at the Atomic Weapons Establishment had been searched on numerous occasions and do not contain the medical records of service personnel.

The claimants say they can prove the nuclear testing was repeatedly ordered over a 10-year period and up to 100% of personnel at some of the sites were affected.

Veterans also claim ministers have repeatedly misled Parliament and that they blocked information being given to their next-of-kin last year.

Played 'genetic Russian roulette with his life' Steve Purse, 49, who was born with short stature about a decade after his father, Flight Lieutenant David Purse, served with the RAF in Maralinga, Australia, where British nuclear tests were carried out, said: "You wonder whether you have played genetic Russian roulette with his life."

"It's as if the MOD are withholding these records because they're a bit frightened of what might come out.

"If they have withheld information that could have saved lives, but, certainly, would have lessened the trauma and would have lessened all the anguish all these families have gone through, then they need to be

held accountable for that because they have done that knowingly and willingly."

The veterans claim their military medical files had been edited to remove all records from their time at the tests, making it difficult to claim war pensions on the basis of radiation-related injuries.

Jason McCue, managing partner of McCue Jury & Partners which is representing the claimants, said if the veterans' GPs had been "given proper access to their military records, there might be many more of them alive today".

The law firm has appealed for anyone who took part in the tests and clean-ups under UK command to contact them if they wish to be part of the legal claim.

Veterans have campaigned for years over illnesses they say were caused by radiation exposure, in a fight which reached the Supreme Court in 2012, where those

involved in 1,011 test cases lost their bid to be allowed to seek compensation.

#### MOD response

A spokesman for the MOD said: "We are grateful to all service personnel who participated in the British nuclear testing programme and contributed to keeping our nation secure and are pleased that they will now be receiving a medal in recognition of this.

"It remains the case that no information is withheld from veterans and any medical records taken either before, during or after participation in the UK nuclear weapon tests are held in individual military medical records in the Government's archives, which can be accessed on request.

"The MOD is not able to comment on ongoing litigation or claims, nor would the MOD be able to comment if they were yet to receive the claim."

## Medals and Awards






### ONE WOMAN'S WAR AND PEACE Wing Commander (Ret'd) Sharon Bown

## Coordinating attacks on Black Dagger



Exercise Black Dagger, the culminating activity for the 72 joint terminal attack controller (JTAC) course, has successfully concluded at RAAF Base Townsville.

The exercise kicked off in early November and required students to coordinate the live and simulated employment of aircraft and ordnance in air-to-ground scenarios.

Exercise Director and Commanding Officer of 4 Squadron, Wing Commander Steven Duffy, said Exercise Black Dagger consolidated everything the JTAC students had learnt throughout the course.

“Black Dagger saw the students draw from six weeks of training in close air support missions, and they were assessed from their planning and briefing to their controlling and reporting,” Wing Commander Duffy said.

“The exercise ensured that the JTACs are ready to call in weapons strikes from air combat aircraft, as well as artillery units and other ground fire, in support of the joint force.”



4 Squadron also deployed the Pilatus PC-21 aircraft, and the exercise was supported by F/A-18F Super Hornet aircraft from 1 Squadron as well as Army elements.

For the first time, personnel from the Republic of Singapore Air Force and Philippine Air Force took part in the exercise – in an observer capacity.

The observers spent a week watching ground activity at the Townsville Field Training Area as well as 1 and 4 Squadron aircraft involvement.

Wing Commander Duffy said international observer participation was beneficial to overall outcomes.

"The interaction was very much a two-way street, with all parties sharing their own knowledge and gaining from the engagement with each other," Wing Commander Duffy said.

"We very much welcomed what the observers brought to the table and it can only benefit us in the future."

Commanding Officer of 1 Squadron, Wing Commander Sean Hamilton, said Exercise Black Dagger provided an excellent opportunity to practice armament procedures and close air support to contribute to the joint force.

"The F/A-18F is well suited to close air support due to its two-seat crew and large payload. Black Dagger provides an opportunity for our air combat group aircrew and ADF JTACs to build close working relationships and enhance our collective effectiveness," Wing Commander Hamilton said.

For Australian Army Captain Craig Macaulay, the opportunity to undertake the course has been an unforgettable milestone in his career.

"The course has been very challenging but superbly rewarding," he said.

"I'm certainly looking forward to applying what I've learnt from this course - knowing it is a massive responsibility in the units that I'm going to be posted to."


